
The Executive Board proposes that the following wording be added to the Articles of Association in Article 11 Convening after the last paragraph:

Public broadcast of the Annual General Meeting may also be provided (Section 102 (4) sentence 2 of the Austrian Stock Corporation Act). If the Executive Board makes use of this authorization, the respective details must be provided in the convening notice. The company is entitled to make audio and video recordings of Annual General Meetings."
